

COMMITTEES UNDER S355

Objective

Under Section 355 (s355) of the Local Government Act 1993, Council is able to carry out some of its functions though a committee of Council. Council uses the power to delegate (s377) and appoints members of the community to form a committee of management. Management committees provide an opportunity for local communities to develop 'ownership' of facilities and services and play an active role in the provision of them.

Introduction

The delegations of functions are limited to the care, control and management of a Council asset in accordance with the Terms of Reference which outlines the function and terms of the delegation.

Policy

Council recognizes the importance of community involvement in Council's facilities and supports the use of its delegated authority under s355 of the Local Government Act to delegate authority to various functions. Council will only authorise s355 Committees under s377 of the Local Government Act 1993 (the Act) where appropriate and in accordance with the Act.

Responsibilities

General Manager: responsible for the overall control and implementation of the policy.

Deputy General Managers & Department Leaders: responsible for the control of the policy and procedures within their area of responsibility.

S355 Committees: are to operate within the delegation given and in accordance with the S355 Committees Information and Responsibilities and S355 Committees Information to aid in the completion of Annual Financial Statements publications provided.

Definitions

S355 committee: a committee of persons vested by Council to exercise a function of Council as provided under the Local Government Act 1993
