The Deputy General Manager Services advised that the second election would commence to elect the second delegate.

The Deputy General Manager advised that a draw for order on the ballot paper would take place by placing the two (2) names on separate pieces of paper and placing them into a barrel noting the ballot will be written in order of the names drawn out of the barrel. The Deputy General Manager Infrastructure shook the barrel and drew the first name that being Clr Nash.

The names were written on the ballot papers and the ballot papers were distributed.

After the collection of ballot papers the Deputy General Manager Services confirmed that all votes were valid and proceeded to count the votes.

The Deputy General Manager Services declared that Clr Nash, having an absolute majority of votes, is elected delegate to Central Tablelands Water.
