MAYORAL MINUTE

It is with sadness that we acknowledge the death of long-serving Cabonne Councillor Kevin Walker. Kevin passed away at his home in Canowindra on Saturday after a long illness.

First elected to council in 2008, Kevin served three terms as councillor and served as Deputy Mayor in 2017. His 13 years of service was underpinned by his devotion to the Canowindra community and the Cabonne shire.

A lifelong resident of the Canowindra area, Kevin was elected as a councillor in 2008 after he sold his hardware business to retire. Kevin wanted to give back and support the community because they had always supported him. Providing for the community and pushing for greater services was always on his agenda.
