Clr O'Ryan commented on the beneficial information provided by CommBank.

# **Banjo Paterson Festival**

Discussions were held regarding the success of the Banjo Paterson Festival events. Clr Weaver expressed thanks to Cheryl Wythes and Jenny Middleton on successful event.

Clr O'Ryan advised the committee that Orange Rotary, who initially instigated the Banjo Paterson Festival will no longer be participating in this event. A meeting with Orange360 will be held to discuss options, an update will be provided to the committee.

As a result of a question from Clr Pull, Clr Jones provided the committee with an overview of the Sheep Dog Trials.

#### **FOOD Week**

Department Leader Community & Economy advised that there is a need to identify ways of engaging more directly with the FOOD Week committee and opportunities to have Cabonne more involved and recognised. It was noted that FOOD Week is recognised as an important event for Cabonne businesses located nearby Orange.

#### Shop Cabonne

- The committee was advised that council has nominated Eugowra for tiny top tourism town awards.
- As a result of a comment from Clr O'Ryan regarding a lack of Cabonne/Molong signage between Orange and Molong discussions were held surrounding the difficulty of obtaining signage space.

### **Events Assistance Program**

Clr Jones advised the committee of an expected sponsorship application from Central West Disc Golf to host Australian Disc Golf Championships in November. Discussions were held surrounding the type of sponsorship they would be seeking. Clr Jones recognised the work of Kevin and Sharon in promoting disc golf throughout the region.

Department Leader Community & Economy advised the committee that the remaining sponsorship figure in report is incorrect

Clr Pull provided an update on the Canowindra Balloon Challenge.

## **Disaster Recovery Update**

Department Leader Community & Economy advised the committee that council has nominated the Disaster Recovery Plan for both a State Local Government award and a National Local Government award.

Council continues to utilise the Recovery Plan updates as a way of keeping track of how we are progressing against projects.

Clr Weaver praised the work being undertaken on council roads.

It was noted the Nyrang Creek bridge was under water over the weekend. Department Leader Community & Economy advised the committee that council is very conscious that this is a point of contention for adjoining communities.

It was noted that basic work has been completed on the ablution block at the Molong caravan park to make it operational. Department Leader Community & Economy advised that the Community Assets Program is focused on betterment of assets, council therefore needs to provide an element of betterment for the projects. This would be done by raising the blocks and providing accessible access. These projects were identified as part of the recovery plan as a result of community feedback wanting to increase tourism back into the area and provide appealing amenities. Cudal and Canowindra had limited project opportunities under this program and it was identified that the betterment of the caravan park amenities provides a good outcome for communities and tourism.

Clr Weaver gave credit to Eugowra Historical Society for their determination in bringing the museum back better.

### DEPARTMENT LEADER COMMUNITY SERVICES UPDATE

Department Leader Community Services provided the committee with a verbal update on the following matters;

- Aged Care Standards Audit auditors pleased with the way council is meeting standards. Good outcome for the Cabonne Home Support team. A performance report will be sent allowing feedback from the provider, prior to a final report being provided.
- 2. Children's Services Grants Council has applied for six grants for After School Care and Family Day Care services. These are for a two (2) year period and will likely receive an outcome in June 2024.

- 3. Seniors Expo Event was well received with approx. 80 attendees. Providers contacting council to attend.
- 4. Meal voucher options looking to be implemented in addition to Meals on Wheels.

# **MEDICAL SERVICES - CANOWINDRA**

Clr Weaver raised the matter of Canowindra losing a doctor and the importance of council advocating for additional medical staff for the town.

Discussions were held surrounding the Rural Doctor's Network, the national body that supports doctor's in rural areas and advocate on their behalf and the new Canowindra Health One Facility.
