GENERAL

1 PROJECT IDENTIFICATION AND DESCRIPTION

This tender is for Contract No. – 1674466 Construction of STAGE ONE DESIGN AND CONSTRUCTION OF THE CABONNE SHIRE COUNCIL TOWN POOLS UPGRADES. The contract will be a Lump Sum utilising the NSW Government GC21 form of contract.

Cabonne Council maintains seven aquatic facilities across the LGA.

The pools are highly valued by the local community they serve. All seven aquatic facilities were originally built over 50 years ago and provide almost identical services due to their similar design, scale and quality.

Unfortunately, due to their age, the plant rooms and water treatment systems require replacement and have noncompliance issues.

Cabonne's Pools are of an older configuration with the filtration rates below recommended. Upgrades to plant room filtration systems can be easily facilitated through system upgrades that utilise common plant, filters, CI analysers, pumps and products that are off the shelf.

Whilst the proposed scope of works is detailed within this document, the Pool Water Treatment Contractor is responsible for the final detailed design and coordination for the installation and commissioning.

Cabonne Council has secured Funding to upgrade the facilities identified in the list below including filtration, plumbing and reticulation systems, energy efficiency improvements and risk mitigation.

Following submission from tenderers and assessment of the submissions, Cabonne Council may elect to undertake the whole of the works or part of the works to fit within the current budget.
