



IMPORTANT NOTICE TO RESIDENTS
Yeoval Water Supply – Level 3 Water Restrictions
Effective Friday 18 January 2019

Council's capacity to supply reticulated water to the residents of Yeoval has been significantly reduced because flows have decreased substantially in the Buckinbah Creek and groundwater availability is unreliable. As a result of this, Council has had to impose Level 3 Water Restrictions. This means that:

Activity	Level 3
Watering of Lawns/ Gardens	Watering Systems, non-fixed sprinklers, hand-held hoses, micro-sprays, drip systems, soaker hoses <u>only</u> – permitted for a Maximum of One Hour per day between 6am and 9am and 6pm and 9pm every second day as per the odds and evens system.
Topping up, filling garden water features	Only between the hours of 7am and 8am and 7pm and 8pm
Irrigation of New Turf	Permitted for one week after laying after which Level 3 restrictions on watering Lawns applies
Washing Down walls or paved surfaces	Not Permitted
Topping up Private Swimming Pools/Spas	Only between the hours of 7am and 8am and 7pm and 8pm
First fill of private swimming pools	Only between the hours of 7am and 8am and 7pm and 8pm
Washing Cars at home	Permitted with bucket and rinse with trigger hose on lawn between for a Maximum of One Hour between 6am and 9am or 6pm and 9pm

Odds and Evens System Explained

This means that if the street number of your property is even you can water in accordance with the restrictions on even days. eg 12 Smith St can water on the 2nd, 4th, 6th...30th of each month. If your property has an odd number, you can water in accordance with the restrictions on odd days. eg 11 Smith St can water on the 1st, 3rd, 5th...31th of each month. If your property has no street number then it should be treated as an even property.

Please note that the existing Yeoval reticulated system supplies residents with chlorinated raw water only, which is non-portable, with alternative sources of drinking water to be arranged by each householder. Your assistance in reducing your water consumption is essential to maintain sufficient supply to residents for essential household purposes.

Cumnock Water Supply – Level 2 Water Restrictions
Effective Friday 18 January 2019

Council's capacity to supply reticulated water to the residents of Cumnock has been significantly reduced because flows have decreased substantially in the Bell River. As a result of this, Council has had to impose Level 2 Water Restrictions. This means that:

Activity	Level 2
Watering of Lawns/ Gardens	Watering Systems, non-fixed sprinklers, hand-held hoses, micro-sprays, drip systems, soaker hoses <u>only</u> – permitted for a Maximum of Two Hours between 6am and 9am and 6pm and 9pm every second day as per the odds and evens system.
Topping up, filling garden water features	Permitted
Irrigation of New Turf	Permitted for one week after laying after which Level 2 restrictions on watering Lawns applies
Washing Down walls or paved surfaces	Not Permitted
Topping up Private Swimming Pools/Spas	Only between the hours of 7am and 9am and 6pm and 8pm
First fill of private swimming pools	Only between the hours of 7am and 9am and 6pm and 8pm
Washing Cars at home	Permitted with bucket and rinse with trigger hose on lawn between 9am and 12noon

Odds and Evens System Explained

This means that if the street number of your property is even you can water in accordance with the restrictions on even days. eg 12 Smith St can water on the 2nd, 4th, 6th...30th of each month. If your property has an odd number, you can water in accordance with the restrictions on odd days. eg 11 Smith St can water on the 1st, 3rd, 5th...31th of each month. If your property has no street number then it should be treated as an even property.

Please note that the existing Cumnock reticulated system supplies residents with chlorinated raw water only, which is non-portable, with alternative sources of drinking water to be arranged by each householder.
